

MASTER RESALE RIGHTS LICENSE AGREEMENT

Product: Digital Products Starter Kit

License Type: Master Resale Rights (MRR)

Effective Date: Date of valid purchase

1. GRANT OF LICENSE

This agreement grants the Licensee (purchaser) non-exclusive **Master Resale Rights (MRR)** to distribute and resell the digital product known as the **Digital Products Starter Kit**, subject to the terms below.

This product operates under a **tiered licensing system**, allowing resale with rights, provided that all conditions of this license are passed along unchanged.

2. RIGHTS GRANTED

Under this license, you are permitted to:

- Resell the product to end users for personal use
- Resell the product **with Master Resale Rights (MRR)** included to your buyers
- Allow your buyers to also resell the product with MRR, provided they comply fully with this license
- Retain 100% of the revenue from any permitted sales
- Promote and resell the course, noting that **course access is fulfilled directly by the Licensor** (Amy Southcott / Phoenix Digital Marketing Solutions) through a verified process

3. RESTRICTIONS

To maintain this license, the following conditions must be met:

- You may grant MRR to your buyers, but **you must pass on this license agreement in full**
- You may not grant **Private Label Rights (PLR)** at any stage
- You may not allow buyers to **alter, rebrand, or modify** the product
- The product **must always be resold for no less than £65 GBP**
- The product **may not be bundled, discounted below its minimum value, or offered as a free bonus**
- Buyers must be informed that **course access is fulfilled directly by the Licensor** through the original delivery system (e.g., hosted course portal)

4. LICENSE LIMITATIONS

This license **does not grant**:

- Private Label Rights (PLR)

- The right to modify the product content, structure, branding, or media
- The right to sell this product on platforms where resale conditions cannot be enforced (e.g., Fiverr, Amazon Kindle)

5. TERMINATION

If the Licensee breaches any part of this agreement – especially pricing, distribution, or modification terms – the license will be considered **automatically terminated**, and the Licensee must immediately cease all sales and distribution activities.

6. NO WARRANTY

This product is provided “as-is” without warranties of any kind. The Licensor shall not be held liable for any claims, damages, or losses resulting from the use or resale of this product.

7. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of **England and Wales**. Any disputes arising out of or in connection with this agreement shall be subject to the exclusive jurisdiction of the English courts.

8. RESALE LICENSE CHAIN

All Licensees must pass on this license agreement in full to their customers.

Each Licensee is responsible for ensuring that:

- Buyers receive this same license agreement
- Buyers understand they are bound by the same terms and conditions
- Access is provided via the original course platform, directly from the Licensor
- No modifications, branding changes, or unauthorized reselling methods are introduced

Any sale made without this license, or in breach of its terms, shall be considered **unauthorised**, and the license for that party shall be voided.

9. COURSE ACCESS & DELIVERY

This digital product is delivered via online course access, which is **centrally managed by the Licensor**.

Each Licensee and their customers will receive access **directly from the Licensor** through the official course platform.

Resellers must follow the approved access process provided by the Licensor to ensure buyers receive timely access.

Unauthorised distribution of login credentials, content, or course materials is strictly prohibited and will result in immediate license termination.

10. DIGITAL DELIVERY & WAIVER OF CANCELLATION RIGHTS

By purchasing this product, the Licensee agrees to **immediate access** and **waives the right to cancel** under the Consumer Contracts Regulations 2013, as allowed for digital content delivered immediately upon purchase.
